  - iii) Licence to Occupy Administrative Desk area at Benllech Library.  
Following a meeting with Ms E Lewis, from the Library – they are willing to accept the terms of the licence, pending an addition to be included that Meeting Area should be added to the plan, also number of meetings held. The legal costs for preparing the Licence will be £335.50. The licence will be ready at the beginning of 2019.
