GENERAL MATTERS (CORRESPONDENCE)

1. The e mail received by Mrs Carol Hulme regarding the incident at the 'Jolly Fryer' Car park, was discussed by the Members, and it was decided that a letter will be sent to the Owner of the 'Jolly Fryer' voicing our concerns.
2. Following e mail received by Mrs Jenet Peers regarding sign post to Llanbedrgoch – the Members agreed that a new sign post should be requested by Anglesey Council.
3. The Clerk announce that a cheque was received by Ms Manon E Roberts (Solicitor) TRE&H in respect of Lease of Toilets - £11,564.50.
4. Confirmation – Purchase Order received by North Wales Police regarding the CCTV - £1,975.00

GENERAL MATTERS

1. A request was made to the Clerk from Mr Richard Edwards (Handyman) asking if the fee for footpath maintenance could be increased from £10 to £15 next year, due to amount of work required on them, regarding health and safety regulations. The Clerk was instructed to find out more details regarding the number and size of footpaths etc.
2. The Members thanked the Clerk for the letter he sent on their behalf to Mr Ron Eglin, expressing their dismay at the failed Community Venture at the Bowling Club.
3. The keys for the Seaside Car park and Benllech Square Toilets have been received, and opened on a daily basis by Mr William Owen. The Chairman and Clerk will discuss matters relating to working hours, responsibilities, wages and contract etc. with Mr Owen.
4. The Annual Risk Assessment for 2019/20 was approved and adopted by Members.
5. Further discussions regarding Funding Various Community Projects were addressed by the Members. Mrs Wenda Owen, presented three quotations on behalf of Llanbedrgoch Community Hall in respect of developing the play area. The Members were very supportive towards this venture. Mr Ieuan Williams was also requested to consult the Head Teacher of Goronwy Owen School, Benllech to find out if a similar venture at the school could be funded by the Council.
