- c) Anglesey Council - Temporary Prohibition of Through Traffic at Lôn Bwlch, Benllech.

- d) A request from Mr D Humphreys (Chair) regarding assistance of Members to tidy up the toilets before the Summer season busy period. The Members agreed to organise a convenient time for everyone.
- e) Discuss purchase of playing equipment for children at Benllech and Llanbedrgoch. The Clerk was asked to enquire about the price of appropriate insurance for the site.
