114 Declarations of Interest - There were no declarations of interest.

115 Presentation by Ms Lizzie Wynn of 'Renew Wales' - Beach Sustainable Development Scheme Benllech. (See presentation summary below).

Following a walk around Benllech with Mr D Humphreys, (Chair), Ms Wynn suggested the following priorities to create safer low carbon levels around Benllech on foot or by bike and improve green spaces, which will lead to more opportunities and incentives to travel around without a car. This in turn reduces traffic pollution, improves public spaces, encourages healthy outdoor exercise and the quality of enjoyment and life between and within these places - this was presented in the following points: - a) traffic calming ; b) alterations to the beach car park to create a green space; c) under-used car park (higher up) to become the main car park. Members were given an opportunity to raise questions regarding the proposed developments, and there was great interest in what could be achieved in developing the area. These issues will be discussed at a later date.

120 General Matters

(a) A vote was taken on the applications received in respect of the Vacant Seat, and Mrs Rhian Mair Jones was co-opted as a New Member to stand on the Community Council for the Benllech A area.

(b) The 2 Tenders received in respect of the refurbishment of Benllech Square Public Toilets were discussed, but a final decision had not been made in this respect. Due to the financial costs involved, Members discussed a number of different options, including the possibility of returning the toilets back to the care of the County Council.

(c) The renewal of the Car Park Lease (Benllech Square) was discussed. No decision has yet been made on this.

(d) Mr Huw Percy of the County Council be invited to the October meeting to discuss a number of issues, such as the lease of the car park, and a number of highway issues etc.

(e) There was an update on the CCTV system following the closure of the Police Office in Benllech - the CCTV system is currently in the care of Llandudno CCTV, until it is relocated to Benllech. (to be discussed further by Members).

(ch) A report of the Personnel Sub-Committee was received from the Chairman, following a meeting with Zoom Mrs Leah Watkins (HR Consultant) re the future of the Cleaner's post. The Chairman and Vice-Chairman visited Mr Owen to discuss the matter. He will be sent a letter and a small thank-you gift for his careful and tireless work in the area. The Chairman confirmed that Mr William Owen would cease work as a Cleaner on September 30, 2020. Administrative arrangements will be made by the Clerk and Mr Carwyn Edwards (Accountant).

(f) An inquiry was received from Ms Emma Beacham, Brynteg regarding funding for outdoor play equipment for children in Benllech. The Chair stated that he had been in contact with Ms Beacham, to discuss the matter.

(g) A discussion ensued following a cause for concern (which had recently come to the attention of the Chair and Clerk) regarding Membership of the Community Council. It was decided to make further inquiries regarding the matter before making a final decision.

- (h) Benllech Remembrance Day was discussed - the Clerk stated that there will be restrictions this year due to a number of factors and restrictions due to the Covid-19 pandemic.
- (i) Following technical problems with Zoom, it is hoped to resolve the matter, so that Ms Eira Parry, (the translator) can be involved in the meetings very soon.
- (j) The possibility of having Santa Clause and adding to the Christmas decorations in the Council area this year was discussed. (For further discussion by Members).
