#### **GENERAL MATTERS**

#### **53** CCTV.

The Clerk explained that only one expression of interest was received in response to the Council's advertisement in the Liverpool Daily Post and Holyhead & Anglesey Mail regarding the upgrading of the current CCTV system. Phonecalls were however received from both Conwy and Gwynedd County Councils ond no further interest was shown following an explanation of the nature of the necessary work.

The CCTV Services, Llandudno' email expressed an interest in the upgrading work and was discussed by members. Their proposal would be on similar lines to that of "Trefi Mon" which was completed recently. One benefit would be the live link from the cameras in Benllech to the

Police Headquarters in Llangefni. New cameras would be required together with new receiving equipment but the existing camera stations could be retained and new stations introduced if they were required.

RESOLVED – to request CCTV Services to provide quotations of the upgrading requirements. Also the Clerk to prepare a funding application to the Isle of Anglesey Charitable Trust.

#### 54 BENLLECH ALLOTMENT SOCIETY.

Benllech Allotment Society's email was discussed by members. They were seeking financial help towards improving the track that led from the main road to the allotments. The present surface of the track is unsuitable for vehicles after periods of wet weather and cannot be used from October until the following spring.

The Society had enquired with a local contractor for an estimate of the cost of providing a hardcore surface on the existing track. This amounted to £3946 and was disregarded by the Society as they felt they could not afford such a large sum. The Society's intention was to achieve as much of the work themselves on a piecemeal basis and they were approaching the Council for either financial assistance or a rental easement for two years.

RESOLVED – to agree a rental easement of £200 pa for two years.
