GENERAL MATTERS

168 ESTIMATES 2017/2018.

Following discussions during the January meeting of the Community Council relating to the 2017/2018 expenditure levels, it was agreed to raise the Salaries by £5,000 to allow for the employment of a seasonal worker over the summer period. The amended Estimates schedule shows the inclusion of the new salaries figure.

169 MEMORIAL PLAQUE.

The request from Mr Glyn Roberts to place a Memorial Plaque on the seat above the Wendon was considered by members. Mr Roberts wished the following inscription be placed on the Plaque, "In fond memory of Joyce and Howell. We spent many happy holidays here. You are in our hearts always. Anne and Glyn".

RESOLVED – to agree installing the Plaque with the above wording thereon.

170 SEASONAL WORKER.

The Clerk explained that he had made further enquiries regarding the employment of a seasonal worker from April to October to complete care and maintenance of the Community Council' assets, namely, seats, play equipment, bus shelters and the Public Cemetery. In addition the Village Regeneration scheme needed the planting of flower beds and hanging baskets.

There would be further care and maintenance work if the Isle of Anglesey County Council proceed with the asset transfers of the Library and Toilets.

The intention was to offer a wage of £9 per hour for a 20 hour week, which equates to £720 per month and £5040 over the full summer term.

RESOLVED – to move forward and advertise the post, the Council' Personnel Committee to consider applications and make a shortlist for full Council to consider interview candidates.

171 BENLLECH SQUARE TRAFFIC.

Following a negative response from the village business community to the Isle of Anglesey County Council' intention to place double yellow lines from the Square to the entrance to Tyddyn Fadog Estate in an attempt to relieve traffic congestion at Benllech Square, the matter was discussed further by members.

A short presentation was made by Carol Hume who spoke on behalf of the business community. She suggested that placing double yellow lines was a poor attempt to resolve a larger problem. In her opinion making Llangefni Road from the Square to the junction with Lon Pant y Cudyn one way traffic would be a better option. This measure would contribute to a safer environment around Ysgol Goronwy Owen by reducing the traffic flow in the area. Ms Hume also presented a petition against the County Council measure with over 400 signatures thereon.

Members discussed the situation further with various suggestions to alleviate the problem. However, it was agreed that a collection of measures was required to provide real improvement, perhaps that a complete solution was not possible. It has to be borne in mind that narrow roads built generations ago are not designed to cope with twenty first century traffic flows.

RESOLVED – to call a Public Meeting and invite a Senior Officer from the Highways Department of the Isle of Anglesey County Council thereto.

174 PUBLIC MEETING RELATING TO THE PROPOSED DEVELOPMENT ON LAND AT STORWS WEN GOLF CLUB.

A Public Meeting was held at Brynteg Community Hall to discuss the proposed development of 36 Holiday Cottages on land near to and opposite Storws Wen Golf Club on February 7 2017 at 7-00pm. Present from the Community Council were, Mr Rhys O Jones, Ms Gwyneth M Davies, Miss Nia Williams, Mr Dewi Roberts, Mrs Diana Roberts, Mr Jeff Cotterell and Mr Ieuan Williams who Chaired the Meeting.

Representing Storws Wen Golf Club were, Mr Andrew Cartwright, Mr Rhys Dabvies and Mr Emyr Rowlands.

The Chair gave an insight of the intent to make a planning application and stated that it was an opportunity for the Public and Community Council to ask questions and state their opinions publicly regarding the proposed development.

(Notes of the questions and answers given is supplementary to the Minutes)

The situation surrounding the proposed application was discussed by members at the Community Council meeting. There was a strong view that the proposed development was out of character with the surrounding area and creating a village outside the boundaries of Brynteg village with the holiday cottages at exorbitant prices. Any development should be priced at realistic levels for local young people to get a foothold on the housing ladder. The building of the Holiday Village is seen as taking advantage of a loophole in the Local Development Plan. The cynical view the development as an opportunity to sell properties to future Wylfa Newydd workers.
