### 180 ISLE OF ANGLESEY COUNTY COUNCIL – CHARITABLE TRUST.

Submitted for information – letter from the Isle of Anglesey County Council informing that the Charitable Trust' Regeneration Committee had recommended a grant of £10,000 to the Community Council towards the upgrading of the CCTV System. Confirmation of the recommendation is expected on the 18 April 2017 at a meeting of the full Charitable Trust.

### 181 ISLE OF ANGLESEY COUNTY COUNCIL – ENFORCEMENT TRIAL.

Submitted – correspondence from the Highways department of the Isle of Anglesey County Council informing the intention to hold a trial by employing the private company "Kingdom" starting in early summer 2017 when they will issue fixed penalty notices of £75 for all littering and dog fouling offences. The County Council were seeking the Community Councils views and support on the trial.

#### **GENERAL MATTERS**

#### 189 APPOINTMENT OF INTERNAL AUDITOR 2016/2017.

The appointment of the Internal Auditor in respect of the Community Council' accounts for 2016/2017 was considered by members, it was suggested that a request be made to Mr John Roberts and this was supported unanimously.

### 190 ISLE OF ANGLESEY COUNTY COUNCIL – BRIEFING NOTE ON SPECIAL DISPENSATION.

An email was received from the Chair of the Anglesey County Council' Standards Committee which included a Briefing Note and an amended application form for members use, relating to Special Dispensation.

The Standards Committee request as much notice as possible of an impending request for Special Dispensation especially if it relates to a number of members from the same Council. Ideally the Committee require a minimum of five working days notice between date of receipt of the application and date of the Community Council meeting the Special Dispensation is relied upon.

A copy of the Briefing Note and the Special Dispensation application form was delivered to each member at the same time as the March Agenda.

#### 191 SEASONAL WORKER.

The Clerk explained that he had not placed an advertisement for the post of Seasonal Worker in the local press due to the exorbitant cost involed. For placing an advertisement in the Daily Post and the Holyhead & Anglesey Mail the cost was £699 + VAT for a single day. For the Holyhead & Anglesey Mail alone the cost was £399 + VAT, again for a single day.

Following discussions by members it was decided to place the relevant advertisement on the Community Councils' website and the "Arwydd" together with relevant websites. It may also be possible to place the advertisement on the Isle of Anglesey County Council website.

### 192 ISLE OF ANGLESEY COUNTY COUNCIL – DRAFT LIBRARY SERVICE STRATEGY.

A letter was received from Delyth Molyneux, Head of Learning, Isle of Anglesey County Council relating to the Draft Library Service Strategy 2017 – 2022 and the consultation process on the future of the Library Service during the autumn period 2017. The Draft Library Service Strategy 2017-2022 was presented to the Executive Committee on the 14 February 2017. The Executive Committee agreed to authorise officers to conduct a Public Consultation on the Draft Strategy Library Service Strategy 2017 – 2022 following the Local Council Elections on the 4 May 2017.

#### 193 BENLLECH LIBRARY.

The Clerk gave members a short resmu of a meeting with Bethan Fraser Williams of Menter Mon regarding the future of Benllech Library. He explained that Menter Mon had received funding under the Leader programme to expand the profle of the Library Service to a wider audience by holding events that would lead to the transfer of the service to the local community. There would be a requirement to hold three events at the Library on wide ranging topics to include information technology, website building etc. It would also be necessary for the Community Council to have a practical input e.g a presence during sessions.

**RESOLVED** – that the Council move ahead positively as there was no additional cost involved.
