123 Declarations of Interest - one declaration of interest was received from Mr G Harker-Roberts, (Brynteg).

124 Visit by Mr Huw Percy (Highways Department, County Council) - The purpose of the visit was to discuss a number of questions from Members, including issues relating to Car Parks in Benllech - lease and parking charge; the lack of a safe way to walk from Llanbedrgoch to Benllech; discuss the possibility of establishing a One-way system towards the beach at Benllech; Benllech Beach Sustainable Development Scheme (following Ms Lizzie Wynne's visit). (See comments below).

Car Parking Issues in Benllech - Mr Percy provided Members with alternative options regarding lease renewal and a parking charging system (for further discussion by Members).

B5108 Square Road towards Brynteg - One-way system could be piloted by Experimental Traffic Order valid for up to a maximum of 18 months. The road could be made one-way

from the Square to the Pant y Cudyn junction (or any other recommended locations) with traffic flowing down / up from the Square to reduce movement there. The one-way system could be extended to the Pant y Cudyn junction, but this can be reviewed, depending on local opinion, and Fire Service comments. If supported by the Community Council, it would like to proceed with piloting an 18 month Trial Traffic Order and have it in place before Easter 2021. Within the 18 months a permanent Order would either have to go ahead and follow the usual process, or agree that there is no benefit in a one-way system and return to a two-way traffic system. He did not recommend having a different arrangement during the summer months only on a permanent basis. There would be options to retain or increase the number of on-street parking spaces if traffic could only flow in one direction permanently. If there is no support for trialing a one-way system, then we would recommend proceeding with a permanent Traffic Calm to prevent parking from the Square upwards to improve traffic flow. This Order could include modifying parking restrictions outside the butcher's shop to increase turnover.

Beach Road - A one-way system could be piloted by an Experimental Traffic Order valid for up to a maximum of 18 months. The road could be made one-way from below the Square car park entrance to the Upper Wendon car park entrance (or any other recommended locations) with traffic flowing down to the prom, keeping the road from the Upper Wendon entrance to the A5025 through Breeze Hill Estate as two-way traffic. If there was support from the Community Council, he would like to proceed with the trial of an 18 month Trial Traffic Order, and have it in place before Easter 2021. Within the 18 months either a permanent Order would have to go ahead and follow the normal process for that or agree that there is no benefit in a one-way system and return to a two-way traffic system. I would not recommend having a different arrangement during the summer months only on a permanent basis. There would be options to apply for grants to widen the future if the road were permanently one way.

Cllr Ieuan Williams (County Councilor) thanked Mr Percy for his valuable comments.
