## 149 General Matters

(a) Update on the relocation of the CCTV System at Benllech - An estimate was received from CCTV Services, Llandudno for £ 1966.56. Cllr Ieuan Williams agreed to discuss the matter with Mrs Tegwen Morris, Headteacher of Ysgol Goronwy Owen, Benllech. More details to follow in January.

(b) Car Park Lease Renewal was discussed, following correspondence from Mr Huw Percy. Members voted democratically in favor of proceeding to renew the lease.

(c) Cae'r Berllan Insurance - The application for financial assistance from Zurich was refused in respect of the damage done. The matter is to be discussed further.

(d) Zoom Translation - (following correspondence from Mr Aaron Evans IACC) - it was decided to trial the use of telephone translation during the January meeting of the Council, again using Ms Eira Parry as translator.

(e) (i) Request for the installation of a memorial bench by Mrs Megan Moreland.

(ii) Request for the installation of a bench in memory of Mr Pete Regan.

*The Clerk was asked to look for companies (and prices) at the beginning of the year, so that the Council could select benches to buy, and place them in various locations (at the Council's discretion). The public would be able to purchase a suitable bench, and pay for its installation.*

(f) 'Tyddyn Tlodion' Fund - Mr Dewi Roberts gave a detailed and concise report regarding the fund, together with a clear explanation of how the money is administered and distributed annually. The Chairman thanked him for his contribution.
