## 195 General Issues

(a) The 'Council Code of Conduct' was adopted and ratified for 2021-22.

(b) The Chairman reported (on behalf of the Personnel Sub-Committee) regarding the letting of the Beach Toilet Cleaning Services Contract, Benllech. Members previously agreed to delegate the letting of the Contract to the Personnel Sub Committee. Following a successful interview, Mr Owen Sherlock has started work as a Beach Toilet Cleaning Services Contractor. A word of thanks was extended to Cllr. Ieuan and Mrs Carol Williams for their tireless work for some time, looking after the Benllech Beach Public Toilets.

(c) Outcome of New Cae'r Berllan Play Area Consultation by Chair. Responses to the Consultation were disappointing. But the information received was very positive. It was decided to proceed with the initiative. The Chairman was thanked for his hard work in forming the consultation document.

(d) Response of Mr Alan Jones (County Council's Street Works and Enforcement Manager) regarding road issues in Benllech - no further action required – the Clerk was asked to contact Mr Huw Percy (County Council), and invite him to visit the Council meeting in June, to discuss the issues further.

(e) Report by the Clerk - following the County Council Standards Committee. The Clerk received a very positive report, and a formal report from the Standards Committee is expected in due course.

(f) 'Branding' for the new Website - Miss H Owen. Confirmation was received by Miss H Owen, that she would be able to adapt and develop the designs, as requested. The Website sub-committee will meet soon to discuss the matters further.

(g) Correspondence from Mr P K Day regarding caravan letting rights at Beach Road. Members discussed the matter and decided to contact the relevant County Council officials for more information by the next meeting.

(h) Correspondence from Mr A G Evans, Public Rights of Way Officer, County Council Highways Department, regarding Mrs Foster's letter of application to install a handrail on the route from Lôn Conwy towards the direction of the Beach. Members discussed the matter and the Clerk was asked to contact Mr D Hughes regarding costs for the work.

(i) Information from Mr G H Roberts - litter bin set alight - Beach Car Park. The Clerk had contacted the police to report the incident.

(j) CCTV - the Clerk was asked to contact CCTV Services, Llandudno to make inquiries and receive an update on the system, following the closure of the Police Office in Benllech. The possibility of relocating the system to Ysgol Goronwy Owen, Benllech was discussed - and permission was obtained from the Headteacher. It was discovered that the CCTV system was not currently operational - following confirmation from the CCTV Company, Llandudno. There will be an internal investigation of this issue. Following the information received - the Chair, (in conjunction with the members of the Community Council's CCTV sub-committee and other Members) proposed to proceed with an agreement between Ysgol Goronwy Owen and the Community Council. It is hoped to resolve this very soon, to ensure public safety, as it has created a lot of unnecessary confusion and discontent.

(k) Benllech Beach Public Toilets - Cllr. Ieuan Williams reported the sink in the men's toilets needed urgent repairs. The Clerk was asked to contact a plumber and carpenter to carry out the work.
