

Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2025 of **Llanfair Mathafarn Eithaf Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

- Assertion 3: Publication of information

Section 50 of the Democracy and Boundary Commission Cymru etc. Act 2013 requires the Council to publish its audited accounts online. Regulation 5 of the Accounts and Audit (Wales) Regulations 2014 requires the Council to publish the Annual Governance Statement alongside the accounts. Regulation 15 of the 2014 Regulations requires the Council to publish along with the accounts, any certificate, opinion, or report issued, given or made by the Auditor General.

The Council has failed to publish its qualified audit report from 2022-23 on its website.

The Council has not published the audit completion notice in respect of 2022-23. The purpose of the audit completion notice is to inform electors of their rights under the Accounts and Audit (Wales) Regulations 2014 in relation to the audited annual return.

- Assertion 8: Action on all matters raised in previous reports

The issue of the Council not publishing all information that is required to be published was included in the 2022-23 audit opinion, however previous year

audit reports and the audit completion notice in respect of 2022-23 are unpublished.

Our testing identified that the Council makes Section 137 expenditure. However, the Council has stated S137 expenditure in the 'Additional Disclosure Notes' section on the annual return as nil. The issue of the S137 disclosure on page 3 of the annual return not being consistent with accounting records was included in the 2022-23 audit opinion, and has reoccurred in the 2024-25 annual return.

The Council has not addressed all the matters raised in the Auditor General's report on the 2022-23 annual return.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Internal audit report

I draw attention to the negative responses provided by the internal auditor on the Annual Internal Audit Report.

We recommend that the Council actions the findings the internal auditor has identified, namely instituting regular bank reconciliations and recording VAT on invoices in the cashbook, in order to ensure they can provide positive responses in future years.

Capital projects

The Council did not provide any information in relation to capital projects. Information on this was requested as one of the governance themes of the 2024-25 audit.

We recommend that the Council reviews the annual audit notice to ensure that all required information is provided on a timely basis.

There are no further matters I wish to draw to the Council's attention.

Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2024-25 was £10.81 per elector.

In 2024-25, the Council made payments totalling £ 0 under section 137. These payments are included within 'Other payments' in the Accounting Statement.


